Dear Parents:

This notice is to remind those parents who anticipate the need for **before and/or after school childcare** transportation for the upcoming 2018/2019 school year that applications are due **not later than June 1, 2018**. Transportation can be delayed if applications are not received by this date.

**ONCE ROUTES ARE COMPLETED AND DISTRIBUTED TO THE BUS COMPANIES, THERE WILL BE NO CHANGES MADE FOR THE FIRST THREE WEEKS OF SCHOOL. THIS POLICY IS FOR THE SAFETY OF ALL STUDENTS.**

**Childcare transportation requests must be renewed annually.** Please obtain the appropriate form from the Main Office at your child's school or from Census and Enrollment at Howitt. **ALL COMPLETED FORMS MUST BE RETURNED TO THE TRANSPORTATION DEPARTMENT AT 50 VAN COTT AVENUE, FARMINGDALE, NY 11735.**

If we do not receive a new or renewal application, your child's transportation will automatically return to the district policy pertaining to your home address for the coming school year.
